**RE: RELEASES OF HEXAVALENT CHROMIUM FROM MATTCO FORGE, INC., 16443 MINNESOTA AVE., PARAMOUNT, CA 90723**

The Los Angeles County Department of Public Health is issuing the following Public Health Directive to Mattco Forge, Inc. (“Mattco”).

In July 2017, the South Coast Air Quality Management District’s (SCAQMD) air monitoring station at Mattco documented elevated emissions of hexavalent chromium. As such, Mattco is operating in violation of the California Health and Safety Code, and causing a public nuisance that endangers the health of the surrounding community. Hexavalent chromium is a known human carcinogen, and facility operations at Mattco are contributing to significant long-term health risks for the people living and working in the City of Paramount.

Pursuant to section 11.02.190 of the Los Angeles County Code, Mattco Forge, Inc. is hereby directed to:

1. Take all necessary actions in cooperation with the SCAQMD to eliminate the current nuisance endangering the health of the public, which may include partial or full suspension of operations.
2. Notify the Department of Public Health within 24 hours of your intent to comply with this Directive, and submit a list of both actions taken and proposed actions. The Department is working closely with SCAQMD to ensure the elimination of this endangerment without delay. Please copy SCAQMD on all submittals to the Department.
